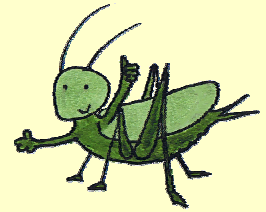

Underage customers must have their order signed by their legal agent. In the case of cancellation or return of an order we reserve our right to charge costs incurred through handling and transport.

PAYMENT

DELIVERY

The delivery takes place within the 14 days following the invoice settlement in the case of prepayment or 14 days after the order's arrival at our company. We deliver via mail or small package services. Damage has to be claimed immediately at the delivery service.

The purchaser is obliged to check the arriving goods for correctness and completeness. Possible faults must be reported in the 5 days following the goods' delivery.

RETURNED GOODS

The return of goods is only possible after prior consultation. In the case of a legitimate reclamation, we assume the return costs. If no error is on hand from our side, the return costs are assumed by the client. Unfortunately, books ordered by accident cannot be taken back.

NON-LIABILITY

Mistakes, misprints, order taking errors excepted.

WARRANTY

For warranty and liability claims, the delivered goods are taken back and replaced without charge.
